



**Saguaro Football
Tax Credit Drive
Support 2017 Nevada Game**



What is a Tax Credit Drive?

A tax credit drive allows you to make a donation to Saguaro Football now and receive a dollar-for-dollar offset against your State Income Tax for either 2016 or 2017. Depending on your circumstances, your contribution may also result in a federally deductible charitable contribution.

Who can participate?

Anyone that pays taxes to the state of Arizona can make this contribution to our football program. That means your friends and family can participate in your child's name too. Extra donations will be used for coaches' airfare and other travel related expenses for the team.

What is the deadline to make my contribution?

We are asking that you make your contribution between **March 16th and May 25th** so that we can secure travel arrangements for the team. Gov. Doug Ducey has signed a new law that moves the deadline for tax-credit donations to public schools from Dec. 31 to April 15 so you can still qualify for a 2016 tax credit if you contribute by April 15th, 2017. After April 15th, 2017 it will qualify for a 2017 tax credit.

What do I need to do?

Arizona tax law (ARS 43-1089.01) allows taxpayers a TAX CREDIT of up to \$400.00 for married filing jointly and \$200 for single filers if they contribute to extracurricular activities in public schools. This tax credit is available only to individuals in Arizona. Payments must be received by December 31 in order to apply the tax credit to that calendar year.

To make a donation:

1. Enter in your name, address, phone number and email address.
 - All fields are required.
 - if you don't have an email address, please use scrozier@susd.org.
2. Select the school and tax credit item from the drop-down box. You may enter a memo or student name in the memo field.
3. Enter in the amount of the contribution and click add. You may select multiple schools or tax credit items.
4. When you are finished, click on the Pay button.
5. Enter in your card information and click Submit Payment.
6. You may either print out your receipt or e-mail the receipt to print at a later time.

Note:

Your contribution can be used for a dollar-for-dollar offset against your Arizona state income taxes. Consult your tax advisor to see how this applies to you. Beginning in 2016, credit eligible fees paid and contributions made to a public school from January 1 through April 15 of a calendar year may be used as a tax credit on the prior year's tax return. For example, qualifying contributions made to a public school January 1, 2017 to April 15, 2017 may be used as a tax credit on either your 2016 or 2017 Arizona income tax return.
